 - Commercial heifers will be shown by weight.
 - There must be at least five heifers of one breed to constitute a breed class. All Others will be placed in other breeds class.
6. Steer information:
 - Steers will be shown by weight. There will be no breed classes.
7. Premiums will be paid out according to number of entries.
8. Showmanship will be as follows: Age 9 – 12, age 13 – 15, age 16 – 18.
9. The Rabun County Fair Association nor anyone or anybody associated with the show are not liable for accidents, injuries or theft.
10. Exhibitors are responsible for his or her own animal and assume all risk associated.
11. Weight in will be from 12:00 PM until 5:00 PM
